### Subject: Modalities for issuance of Protected Area Permit (PAP) - regarding

Sir/Madam,

I am directed to reiterate that all foreigners will require Protected Area Permit (PAP) to enter the State of Manipur. However, due to pending prerequisites, such as login credentials and VPN dongles from NIC HQ, Delhi, which are likely to delay the operationalization of the online issuance of PAP through the e-FRRO portal, the State Government has decided to facilitate foreign nationals in applying for PAP through the following interim measures:

- i. Foreigners arriving in the State without an online PAP will be required to fill out the existing physical PAP application form, enclosed as **Annexure-I**, at designated entry points—Imphal Airport, Mao Gate, and Jiribam Gate. These applications will be manually entered into the e-FRRO portal by the office of SP, CID/SB.
- ii. Each foreigner will be required to sign an undertaking (enclosed as **Annexure-II**), affirming that they will exit the State immediately if their PAP application is rejected on the e-FRRO portal.
- iii. All district SPs are directed to closely monitor the activities of foreigners during their stay to ensure compliance with permissible activities.
- iv. The above interim arrangement (i) to (iii) shall not be applicable to citizens of Pakistan, Afghanistan and China
- 2. You are requested to ensure strict compliance with the above directives and coordinate with all relevant authorities to facilitate the implementation of these interim measures effectively.
- 3. This is issued with approval of the Competent Authority and in continuation of letter of even number dated 21<sup>st</sup> December 2024.
